Makan Delrahim of the DOJ Previews Hatch Center Music Licensing Event

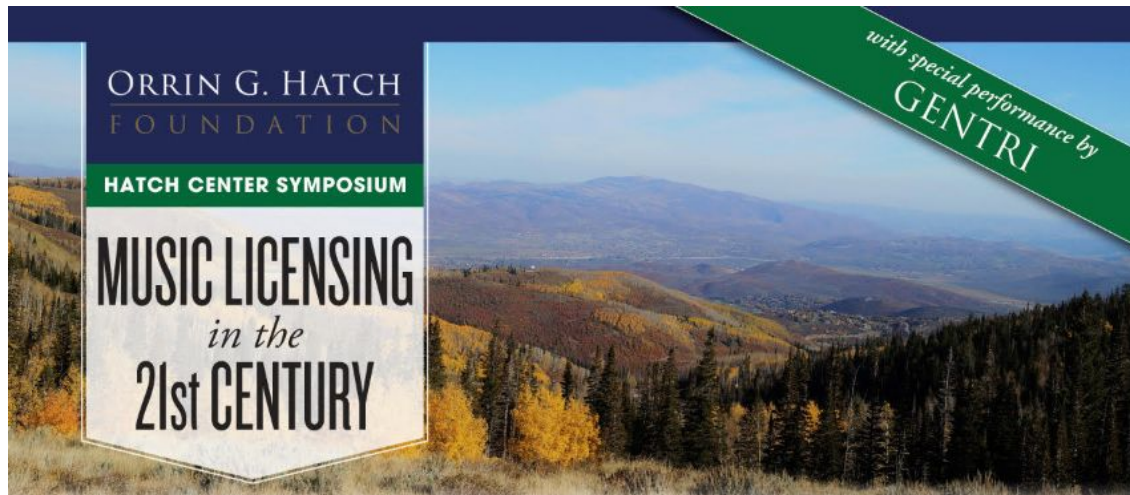

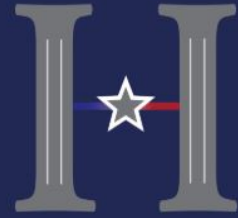
